

2. The Board shall appoint the Twinplex Subcommittee (the "Subcommittee"), which shall, subject to the limitations set forth hereafter, have the authority to generally govern the Twinplex community by setting the Twinplex budget for payment of the Expense elements, including those set forth

1. The Original Declaration, as amended hereby, constitutes the "Declaration". In the event of any conflict between the provisions contained in the Original Declaration and those contained herein, then the provisions contained herein shall control. Except as otherwise set forth herein, all provisions of the Original Declaration remain in full force and effect and without modification.

NOW, THEREFORE, in consideration of the foregoing and for other good and valuable considerations, it is agreed that the Original Declaration is amended as set forth hereafter.

WHEREAS, Developer and McClinton are a Majority of Owners and Holders and have affirmatively voted to effect the amendment contained herein; and

WHEREAS, the Twinplex Owners who own the Residential Units (sometimes known as the Meadows) containing a Twinplex and shown on the Plat recorded in Buncombe County Plat Book 108 at page 74 have requested that they be provided a measure of self-rule; and

WHEREAS, all terms which are capitalized herein, but are not defined, shall have the same meanings ascribed to them in the Original Declaration; and

WHEREAS, the Declaration of Village Park Development Planned Community is recorded in Buncombe County Book 4152 at page 1980 and the First Amendment thereto is recorded in Buncombe County Book 4176 at page 1553, and said Declaration and First Amendment, collectively, are the "Original Declaration"; and

This Second Amendment to Declaration of Village Park Development Planned Community is entered into as of this 14<sup>th</sup> day of June, 2008, by Village Park Development LLC, a North Carolina limited liability company, Raymond McClinton and Susan H. McClinton.

in Original Declaration Section 1 (a)(i), (ii), (iii), (iv), (v), (vi), (vii) and (viii). The Board shall appoint the original Subcommittee members. The Subcommittee may establish a bank account for the purpose of handling Twinplex funds, but all checks written on such account shall require two (2) signatures, one of whom must be a member of the Board who does not reside in the Twinplexes. The Subcommittee may establish its own rules, regulations and operating procedures for governance of the Twinplex Residential Units, except as otherwise set forth herein. Notwithstanding anything to the contrary elsewhere herein, the Subcommittee is, at all times, subject to the jurisdiction and control of the Board. While the Subcommittee shall generally have reasonably free reign to manage the Twinplex Residential Units, the Board may limit after the authority of, overrule and/or dissolve (and subsequently reestablish it if it wishes) the Subcommittee at any time, and from time to time, and take control of said bank account, after permitted account signers (which the Subcommittee may not do), and otherwise direct the operation of the Twinplex Residential Unit community. It is always the intention of Developer and McClinton, as well as the Board and the Association, that at no time does the Subcommittee have the authority to do anything contrary to the provisions of the Original Declaration. At such time as more than one (1) of the Residential Directors is someone other than Developer and/or McClinton, then one (1) of the three (3) Residential Directors shall be elected by the Twinplex Owners to and shall serve as a Director on the Board.

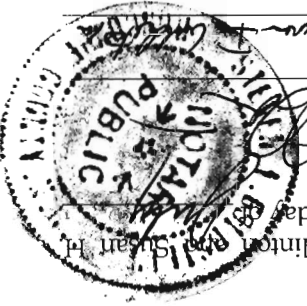
